*Motels / hotels and multi family structures – **Charge per unit**

*Manufacturing warehouse – **Charge 50% of chart value**

*Modular Home – **Charge by Sq. Footage**

Building Permit: *New Tower-* \$500.00 Co-Location/ Upgrade \$ 50.00

*Required permits for damage deemed an act of God – **No Charge**

*ABC *or* Daycare inspection - **\$50.00 each**

-3'x3' at top of exterior stairs is considered a landing and is fee exempt

***Mechanical** -Change out *or* Add on – **\$80.00-**

-New System – **Mechanical sq. ft.** *and* **\$65.00 electrical**

***Electrical** -Service Change (per meter) Single phase - **\$75.00** Three phase - **\$100.00**

-Pump Service, fence, gate, etc. Single phase - **\$60.00** Three phase - **\$100.00**

Storm Damage -No Charge

***Gas piping** - Outside Line - **\$60.00** -Inside Line (per outlet) - **\$50.00**

***Owner/Contractor Change (Active Permits Only) -75% + Complete*Owner/Contractor Change (Active Permits Only) – 75% or less**

\$ - Dependent on percentage of inspections remaining - as the number of inspections for dwellings/buildings vary.

Total inspections necessary for a C/O will be determined on a case-by-case basis following a consultative meeting between the building inspections department and the contractor or homeowner.

Upon determining the total inspections needed for C/O, this number will be divided by the number of inspections completed at the time of the change in owner/contractor.

If this percentage is 75% or greater, a \$100 fee is charged for the new permit. If this percentage is 75% or less, the fee will be based on the number of inspections remaining or \$100 whichever is greater.

For example: If it was determined a 2600 SF home with an active permit required 20 inspections for a C/O and 5 inspections (25%) had been performed at the time of the permit holder change, the new permit recipient would pay \$761.25 or 75% of the \$1015 total building permit cost for a 2600SF home.

This method of charge would be noted on the new permit issued to the recipient.
